A RESOLUTION OF EAGLE MOUNTAIN CITY, UTAH, EXTENDING AN OFFER FOR THE POSITION OF CITY MANAGER AND AUTHORIZING THE MAYOR TO NEGOTIATE AN EMPLOYMENT AGREEMENT

PREAMBLE
