- 2.A. RESOLUTION - A Resolution of the Board of Canvassers Certifying the Official Canvassers' Report of the August 12, 2025 Municipal Primary Election for Eagle Mountain City, Utah

City Recorder Gina Olsen presented the results of the 2025 Municipal Primary Election. The Utah County Elections Office has verified the ballots from the Primary Election with the following results:

- 26,930 ballots were mailed and a total of 6,866 were returned for a 25.5% return rate.
- 23 provisional ballots were issued, of which 2 were not counted due to incomplete information on the provisional ballot form.
- 124 ballots were returned but not counted due to missing signatures (3), signature discrepancies (3), or returned past postmark deadline (116), other reasons (2).
- 310 residents voted in person on Election Day (or an early vote center).
- 5 UOCAVA ballots were issued and returned through Enhanced Voting.
