PROCLAMATION OF THE MAYOR OF EAGLE MOUNTAIN CITY

WHEREAS, the portion of Eagle Mountain City north of State Route 73 and west of Spring Run Parkway, as shown and incorporated herein as Exhibit A, is suffering from a short term scarcity of water;

WHEREAS, Eagle Mountain Municipal Code Section 13.20.180 empowers the Mayor of Eagle Mountain City to limit water use in times of scarcity of water when necessary for the public good; and

WHEREAS, the Mayor and City Council have determined that short term prohibitions on the outdoor use of water in the area of Eagle Mountain City shown in Exhibit A are necessary for the public good.

NOW, THEREFORE, the Mayor of Eagle Mountain City hereby proclaims the following:

1. The outdoor use of water in the area of Eagle Mountain City shown on Exhibit A is hereby prohibited.
2. This prohibition shall last from July 10, 2024 and extend until 11:59 p.m. on July 14, 2024.
